TOURNAMENT RULES AND REGULATIONS

*** USBC Sanctioned ***

20th Annual Gallatin USBC Mixed Doubles Tournament The Bozeman Bowl

- 1. All adult members of the Gallatin USBC Association are eligible to bowl in this tournament. Non-members of the Gallatin USBC may enter by paying an affilitate membership fee of \$26.00 as long as they do not bowl in another association.
- 1. **BOWLER REPONSIBILITY** –See Rule 319, in its entirety for rules pertaining to determination of average and bowler's responsibility for verification of average.
- 2. ENTERING AVERAGE —Highest sanctioned average will be used to figure handicaps. A Gallatin USBC 2024-25 Season Book Average is used to figure handicaps; if no Gallatin USBC Average is available, a Gallatin USBC 21-game average from the current season may be used. If no previous season average or 21-game current average is available, then a 21-game average from the Gallatin USBC 2024-25 season may be used. 2025 summer season sanctioned Gallatin USBC average shall be accepted, provided the bowler does not have an acceptable regular season average. *** Those bowlers who have only a sport/challenge average shall use the adjusted league average utilizing the USBC Average Adjustment Scale (see Rule 201c in its entirety). *** The Tournament Manager may adjust an entrant's average upward prior to bowling. ALL OTHERS BOWL SCRATCH. Corrections in average may be made up to the completion of the first game of a series or within 48 hours if the Tournament Manager has given written consent to the extension of time.

CONDUCT –

- a. Unsportsmanlike behavior will not be tolerated on the lanes or inside the bowling venue. Individuals are subject to ejection for engaging in improper tactics or conduct, including but not limited to, physical and/or verbal abuse toward other persons. Players must exhibit proper respect to bowlers and organizers.
- b. All Entrants must be preset by the start of the first game.
- c. To keep the tournament on schedule, a time limit will be set for the completion of each squad, except in the event of equipment breakdowns.
- 4. The bowlers on a doubles team scheduled to bowl alone on a pair of lanes may set their own pace as long as they do not interfere with the bowlers on adjacent lanes.
- 5. No non-bowlers will be allowed in the bowler seating area.
- 6. Doubles teams shall be comprised of one male and one female bowler.
- 7. Entrants may bowl more than once, subject to these conditions:
 - a. Participants may bowl the event more than once provided they are a paid member of the Gallatin USBC and are eligible according to Rule #1.
 - b. Participants may bowl as many times as they want, but may place only once on the prize list with the same partner.
- 8. Prize ratio as follows dependent upon the number of entries: Pays at least 1 for six entries. PRIZE FEES RETURNED 100%.
- 9. Copies of the USBC Rules are available online http://bowl.com.
- 10. Report all substitutions to the Tournament Manager at least 30 minutes prior to squad time. In case of protest, contact Tournament Manager immediately.
- 11. If a check is returned for insufficient funds, the bowler will be responsible for the insufficient funds fee charged to the Gallatin USBC Association.
- 12. Tournament will start Saturday, November 1, 2025 and end on Sunday, November 2, 2025.
- 13. ENTRIES CLOSE ½ HOUR PRIOR TO SHIFT REQUESTED. Telephone reservations may be made by calling the Tournament Manager Angela De Haan-Lovaas at 406/522-9873. Telephone reservations will be voided if the entry form and entry fee are not received withing seven days of the reservation being made or by the entry deadline, whichever occurs first. Scheduling will be subject to lane availability.
- 14. ALL ENTRIES MUST BE ACCOMPANIED BY ENTRY FEES -

Payable to the "Gallatin USBC Association". **NO EXCEPTIONS**

- 15. All City Tournament prizes will be awarded within thirty days of the end of the tournament. All tournament checks must be cashed within thirty days. Please be advised that the Bozeman Bowl will no longer cash 3rd party checks.
